The top 25 individual Associates in Malaysia will be rewarded a spot to IsaRally Seoul!

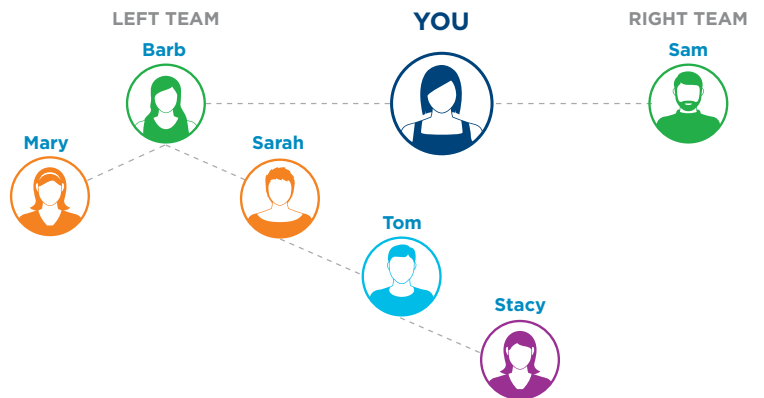
BUILDING YOUR 4PET

To participate in the IsaRally, you will need to build your business by enrolling new 4PET members. Here's how it works: you enroll a new Associate (1PET), who enrolls a new Associate (2PET), who enrolls a new Associate (3PET), who enrolls a new Associate (4PET). Any of your personally enrolled team members who were enrolled prior to the start of the IsaRally are off limits – these must be completely new enrollments. (See FAQs for additional details).

4PET EXAMPLE

You enroll Barb and Sam. Barb enrolls Mary and Sarah. Sarah enrolls Tom. Tom enrolls Stacy.

Success in this challenge is all about the power of duplication! Link arms with new 4PET members to generate the most volume in the contest period.



FREQUENTLY ASKED QUESTIONS

1. Is registration required and how do I register?

Registration is required for all Associates participating in the IsaRally Seoul contest. Registration is open throughout the entire contest period from 1 October 2018 to 3 February 2019. Log into your Back Office, go to the “Contests & Promotions” tab and click “Register” to enter all details.

2. Do new enrollments made by my current 4PET in the contest period count toward my qualification?

No, each member starts with a brand new 4PET at the time of the contest.

EXAMPLE OF BUILDING YOUR NEW 4PET

Building on the previous example, Barb, Sam, Mary, Sarah, Tom, and Stacy were previously enrolled before the contest began, so they do not count towards your qualification. Although, Bob was enrolled by Mary after the contest began, he still would not count towards your qualification because Mary was previously enrolled. To create qualifying volume in the contest, you enroll James as a personally enrolled team member. James enrolls Ann. Ann enrolls TJ. TJ enrolls Katie. All of the volume generated by these new members during the contest will count towards your qualifying volume.

3. When can I get started building my 4PET and accruing BV?

BV for your new 4PET accrues from 1 October 2018 to 3 February 2019. BV accrues cumulatively during the contest period. New Associates you enroll must be quality enrollments; each new Associate must:

- Be 18 years or older.
- Be a citizen or tax-paying resident of Malaysia.
- Have paid their own membership fee on the Isagenix website.
- Have met all other enrollment criteria in the Policies and Procedures.

4. How can I keep track of my 4PET BV?

BV generated by your 4PET will be conveniently displayed in your IsaRally individual report in your Back Office. You can view the report by visiting the “Reports” section under “Business.”

5. How do product returns affect my BV total?

Any product returns will be deducted from your overall BV total after a return order is received by our returns warehouse and processed at the Isagenix Corporate Office.

6. What if one of my 4PET members is in an international market?

As long as you have your International Sponsorship, all BV in the new 4PET will be counted regardless of the enrolling country. For more information about International Sponsorships, please visit IsagenixBusiness.com.

7. What if my account is under compliance review?

Compliance matters will affect your eligibility to participate in IsaRally and may lead to immediate disqualification from the contest. If your account is under compliance review at any time during the contest and you are found to be acting in a noncompliant manner, or in a manner which Isagenix believes does not fit in the spirit of the contest, you may be disqualified from the contest.

8. How can I claim my prize?

The winners will be announced in the month after the contest closes. One prize per winning account will be awarded, which includes airfare, accommodations, hotel transfers and other activities. (See “WHAT YOU WIN” section in this flyer.) We recommend making sure your schedule is clear from 25 April 2019 to 28 April 2019. The prize is non-transferable and no cash equivalents will be given if the winner(s) cannot attend. If you cannot attend, Isagenix Corporate may allow your recognition partner (Spouse only), who has been widely listed on the recognition name of the account for the entire contest period to claim your prize. 9. Do Customers and Associates count toward my 4PET volume requirement?

Yes, any new 4PET enrollments of Associates, Preferred Customers and/or Customers from markets participating in the Customer First Program will count toward the requirement.
